Subject: Clarification of point (3) in the circular dated 26th June 2020

Dear Principal,

This has reference to the CISCE circular dated 26th June 2020 regarding the Council's decision to cancel the remaining papers of the ICSE / ISC Year 2020 Examinations. Some Heads of schools have sought clarification on point (3) in the circular which reads as:

“If the situation is deemed conducive, in the near future, CISCE may give an option to candidates to write any or all of the remaining papers of the ICSE / ISC Year 2020 Examinations at a later date whereby the marks so obtained by the candidate in that written examination(s) shall be considered as their final marks.”

The CISCE would like to clarify that after the declaration of the ICSE / ISC Year 2020 results, this option will be given only to those candidates, who are not satisfied with their results and would like to improve their marks in a particular subject/s for which the examination was not conducted.

These examinations would be conducted by the CISCE within a period of 1 - 2 months from the date of the declaration of the results, subject to the containment of the Covid-19 Pandemic and the overall prevailing conditions in the country. The schedule for the same will be declared at a later date.
